Design cards based on any list view, analytical chart, user-defined objects and tables, or user-defined query, showing the data you need from various aspects.




User-defined queries (UDQs)



Identity and authentication management (IAM)



IAM functionality

- A single set of login credentials can be used across multiple platforms, applications, and networks.
- Sign in to SAP Business One and supported components with your identity provider user – supporting Active Directory Federation Services (ADFS), Azure AD, Okta, and Identity Authentication service from SAP as OpenID Connect (OIDC) identity providers, as well as backward compatibility for Active Directory integration.
- Two-factor authentication is used within SAP Business One authentication service.
- Single logout is supported when an identity provider logs user out of all Web-based pages in SAP Business One.

Cloud and extensions

- Log into Service Layer with a Windows domain user account after activating Active Directory Domain Services and binding its users to company users.
- Cloud 1.1 PL19 supports the deployment of FP 2208 and higher without IAM (future cloud version will support IAM implementation within cloud control center).



Sign-in

- The localization and version information are visible in the *Choose Company* window when you log into SAP Business One client, mobile service, and IMCC.
- The company that user logged in last time is selected by default in the *Choose Company* window.
- *Change password* option appears on the login page when you log into SAP Business One with the bound user account.



User binding

- Bind users from SAP Business One client.
- Multiple company user binding is possible by selecting more than one company when binding an identity provider (IdP) user to a same company user.
- When binding an IdP user to a company user code, if the user code is newly defined for all selected companies, the label “New” shows after the user code. The default user code is the IdP user name.






